WORKS IN PROGRESS:

- Body Rights—This article builds upon my prior work in *The Law of the Body* to examine how a property interest in the body would confer due process protections to the body, with particular attention to regulatory takings and nuisance. This piece asks the fundamental due process question of "what are we owed," in terms of fairness, when the State limits our capacity to use, enjoy, or alter aspects of our own body.
- The Specificity Fallacy —This article challenges the claim that due process can be effectively or objectively mediated by the Dobbs specificity standard (requiring a careful statement of a right rooted in history and tradition). Starting from the premise that due process is a promise about fairness, this article argues that the coherence of concepts like fairness depends upon reason-giving. Using the device of specificity to try to avoid difficult, value-laden questions only serves to undermine reason-giving and create space for uninterrogated reasons to determine outcomes.
- Sacrifice—The thesis of this piece is that legal decision-making often implicitly adopts a gendered concept of sacrifice. When balancing the risks and benefits of legal rules, legal decision-makers disproportionately demand that women sacrifice their time, health, autonomy, fertility, safety, and ambition in service of broader social goals.
